Important Information For Your Bridal Service

To help us serve you better, and to ensure that your wedding day runs smoothly, we ask you and your wedding party follow these simple guidelines:

- Bring your headpiece, veil, and any hair accessories to your trial and the day of your wedding.
- Bring pictures of different hairstyles that you are interested in for the hair stylist to consider. *Note: Pinterest is inspiration, not expectation.* Pinterest pictures are often photoshopped and unrealistic in terms of color accuracy and quality.
- When you make your appointment, we reserve this time especially for you. To hold this time, we require a non-refundable deposit of \$200.
- The final list of guests and their services should be filled out on this contract and submitted to us. There is a 30-day cancellation/change policy. If there are any changes (additions, cancellations, etc.) please inform us as this allows us to properly plan and book additional staff to work your party. Changes made after the 30-day deadline, and no-shows or same-day cancellations, will require payment in full. **No exceptions.**
- Arrive with clean, dry hair to help the hold of your hairstyle. If you wash your hair the day of your wedding, please do not condition it.
- **IMPORTANT:** Please be on time for your wedding day appointment—including your wedding party. Everyone should be available at your designated start time. Even beginning 15 minutes late will put everyone behind, and we do not want you to be late for your special day!
- If a member of your party or guest would like to add a service on the day of the wedding, it will be at the sole discretion of the technician. These additional services must be paid in full and only cash will be accepted.
- If you are the host/hostess, please encourage your guests to choose their services as soon as possible. This allows you to submit the contract and secure your date before it is booked by another guest.
- Weddings that fall on holidays, holiday weekends, or Sunday will require an extra fee.
- Total balance due for services must be paid two weeks prior to the wedding date. *20% gratuity will be added to the final invoice.*
- Travel fees: A travel fee of \$25 per technician will be added if you are requesting a technician to come to your location. An additional fee will be charged for locations outside of a 20-mile radius of Tinley Park, Illinois (60477). The amount will be determined at time of inquiry. All costs for travel to a booked event are to be paid by the client. Costs may include, but are not limited to, parking, valet, tolls, airfare, hotel accommodations, and transportation. **No exceptions.**

- All prices, service, and policies are subject to change without notice.

Wedding Parties at Sona Bella

- You are welcome to bring your own ready-to-eat food and beverage (no on-site beverages). A table or counter will be set up for you where you can place your items along with your paper plates, cutlery, glassware etc. We can put your drinks in our fridge to keep them cold.
- We regret that we cannot serve alcohol. If you wish to bring alcohol to your party, Sona Bella and the technicians will not be liable.
- We reserve the right to refuse service to anyone demonstrating inappropriate behavior to any member of our staff or patrons.
- Services will begin promptly at the time indicated in the contract, with the services performed in rotation between the guests in the party. Because our time is reserved specifically for your party, guests arriving late will not be guaranteed full service time, but will be responsible for services reserved.
